Master Plan Survey Results 2014-11-20

Overview

In late 2013 the Madbury Planning Board initiated an update to the Master Plan, last updated in 2003. As a first step, it was necessary to determine whether the 2003 "Vision for Madbury" was still valid ten years hence. Since much of that vision was formed from the results of a 2003 community survey, it was determined to undertake a similar study with similar questions.

The new questionnaire was made available to residents for approximately one month beginning at the 2014 Town Meeting. Some relevant findings include the following.

- 1) 70 surveys were completed and tabulated.
- 2) 54% of survey respondents have lived in Madbury over 20 years.
- 3) 70% of respondents were 50 years or older.
- 4) The main reasons why respondents like living in Madbury are:
 - a) Friendly atmosphere (71%);
 - b) Natural amenities (61%); and
 - c) Quality of schools (54%).

Background

The "Vision for Madbury" as expressed in the 2003 Master Plan is to "be a quality residential community that preserves and maintains the Town's historic and rural character". To achieve this goal the Master Plan notes several "Major Public Issues":

- 1) Water Quality and Quantity;
- 2) Madbury's rural atmosphere and landscape;
- 3) Community Safety and Services at an Affordable Price/Stable Tax Amount; and
- 4) Balancing Economic Development with Environmental Protection.

A seven part questionnaire was published to survey the community as to citizens' attitudes toward current policies. The questionnaire appears as Attachment A. A tabulated summary is contained in Attachment B. Summarized results can be seen online at www.madburynh.org/Survey.

Discussion of Results

Several questions which requested a "level of agreement" were tabulated as follows.

Level of Support	Header

A value of 2/3 (a super majority) was established as a baseline for determining support.

Pro entries are green when total > 66%.

Con entries are red when total > 66%.

Survey Section 1 shows overwhelming support for 5 key issues with groundwater protection at 97%.

Summary

Based on the results of the survey the following conclusions are suggested.

- 1) Older and and long-term residents are more likely to complete the survey.
- 2) The survey results would seem to support the 2003 Community Vision.
- 3) The results appear to be consistent with the major Issues of the 2003 Plan.
- 4) Survey respondents were generally satisfied with the town's services and like living in Madbury.
- 5) Respondents favored agriculture or home-based businesses including bed & breakfasts.
- 6) The results indicate support for senior housing, but not housing requiring increased density.
