Master Plan Inputs: Madbury Community Club (MCC), September 15, 2016

- Master Plan Update Committee member Mark Avery met with the MCC to collect community input for the Master Plan revision. The club member's inputs are summarized below.

- Broad Themes
 - -- Protect the town's land and water; maintain the town's rural feel.
 - -- Promote a town center that matches the character (i.e., rural, New England) of town
 - -- Encourage land use planning that will allow for less expensive housing.
 - -- Educate new residents on water and septic protection
 - -- Address quality of life issues

- Specific Inputs

- -- Concerns over tree cutting in civic zone and around town
- -- Sensitivity to loss of rural atmosphere in center of town
- -- No clear cutting for new library
- -- Forest near Moharimet should remain forest
- -- Continue town's proactive effort in conserving land. Currently striking a good balance
- -- Town is good about protecting water
- -- Work toward identifiable town center. Promoted library at the core
- -- Interest in solar arrays for town including new library
- -- Encouraged use of small citizen groups to address town issues
- -- Suggested education for newcomers to learn about land and water protection, including septic use and maintenance
- -- Instead of 2-3 acre zoning everywhere, suggested "land-based" zoning
- -- Cost of housing is a concern. Working people can't afford to live here
- -- Suggested areas for multi-family housing and, or for smaller more affordable housing
- -- Roads are narrow and curvy. Modernize roads; make roads wide and safe for walkers and cyclists
- -- Intersections of 155 and Town Hall Road / Madbury Road are dangerous. Speed on 155 is too high including near Tibbets field. Recommended a traffic light
- -- Concerns expressed over
 - --- Noise pollution from Pease flights
 - --- Air pollution from backyard fire pit, rubbish burning at Old Stage campground, sludge fertilizing at Kingman Farm. Want clean fresh air
 - --- Light pollution. Suggested downward directed lighting
